The French investor Wendel bought Constantia Flexibles for € 2.3 billion in 2015. During his career, Unger worked for VAW Aluminium AG for five years as CFO, among other tasks, before switching to Metro AG as CFO in 2002, where he was appointed deputy CEO in 2008. In this position, Unger, who is a graduate in industrial engineering (TU Berlin), was responsible for the Media Markt and Saturn electronic stores, for the Galeria Kaufhof store chain, and the Group’s real estate segments (METRO Group Asset Management), as well as the internal audit department.
